**2017-2018 TAX COLLECTIONS:** All Personal Property, Special Assessments/Charges and one-half of Real Estate Taxes (First Installment) are due **January 31, 2018**. Special Assessments and Special Charges **cannot** be postponed, as these amounts are due with your First Installment and will be taken out of all payments first which could leave a portion of your Real Estate taxes delinquent if enough funds have not been included to cover all Specials, plus the First Installment.

**2018 – Wednesday, Jan 31 8:30AM – 2PM**

**PLEASE MAKE CHECKS PAYABLE TO: TOWN OF VIENNA. SEPARATE CHECKS ARE REQUIRED FOR DOG LICENSES.** We suggest you mail your check to: Town of Vienna, Nicole Roessler Treasurer, 7161 County Rd I DeForest, WI 53532. **If you would like a copy of your printed receipt, you MUST provide a self-addressed stamped envelope with your mailed payment. If you are dropping your payment off during non-treasurer hours you must provide a self-addressed stamped envelope if you want a printed receipt. A receipt will not be sent unless you provide the self-addressed envelope. All the above is applicable to Dog licenses also. You must provide a self-addressed stamped envelope for all dog licenses if not paying directly with the treasurer during open treasurer hours.** For those concerned about deadlines, please mail your payment at least a week in advance as the postmark will be used to determine payment date. Please provide as much detail on tax bills noting payment disbursement on multiple parcels by indicating 1<sup>st</sup> Installment or Full Payment as well as a **TELEPHONE NUMBER**. For your convenience, a secured drop-box is available in the vestibule.
